Apply as a foliar spray at the rate of 2 qt per acre with sufficient water for thorough coverage (100 gal of water per acre is recommended).

TURF: Apply 2-4 quarts per acre (2-4 L / acre). Applications can be repeated every 21-28 days. Do not cut grass for 1-2 days after application.

FRUIT & NUT TREES, SMALL FRUITS, GRAPES, BERRIES, CITRUS: Apply 1-3 quarts per acre (1-3 L per acre). Applications may be repeated between fruit-set and ripening. Allow a minimum of 14-21 days between applications.

TOMATO, PEPPER, CUCURBITS: Apply 1-3 quarts per acre (1-3 L per acre). Applications may be repeated between fruit-set and ripening. Allow a minimum of 14-21 days between applications.

VEGETABLES, Apply 1-3 quarts per acre (1-3 L per acre). Repeat as needed.

COLE CROPS, BULBS, HOPS Apply 1-3 quarts per acre (1-3 L per acre). Allow a minimum of 14-21 days between applications.

**COMPATIBILITY:** Compatible with most pesticides and fertilizers. Always do a jar test with pesticides and spray water to ensure compatibility as water quality may vary. **Add tank-mix partners in the following order:** water, agrochemical, Konnect™.
